Nominations for all categories may be either living or posthumously. A member of the DeKalb Area USBC Association must make the nomination. There will be a maximum of Five (5) inductees each year. The years that there are no applications for the Hall of Fame, there will be a search performed by the Hall of Fame committee for the following year.

Hall Of Fame Qualifications

To be eligible for consideration for the Hall of Fame, the applicant is required to meet the requirements of the category in which you feel the applicant is best qualified. Please be sure that you fill out the application as completely as possible to meet the criteria.

Meritorious Service

To qualify for the Meritorious Service category, a member of the DeKalb Area USBC Association must have met at least six (6) of the following criteria:

- Served as an officer or director of the local association
- Served as chairman of an association committee
- Served on an association committee
- Worked during a local championship tournament (examples include keeping score, verifying scores, tournament desk, etc)
- Served as a local league officer
- Served as a state officer or director
- Served as a state delegate
- Served as a USBC delegate
- Have made exceptional contributions to bowling
- Attended local association meetings
- Attended local/state workshops and jamborees
- Have actively been involved in the promotion of bowling in areas outside the association normal yearly activities

Lane Performance

To qualify for the Lane Performance category, a member of the DeKalb Area USBC Association must have met a least four (4) of the following criteria:

- Held an average of 200 (men) 170 (women) or more for a minimum of five (5) years in the DeKalb Area USBC Association
- Have won a local championship (Team, Singles, Doubles, and/or All Events)
- Have won a state championship (Team, Singles, Doubles, and/or All Events)
- Have won a USBC Open and/or Women's National Championship (Team, Singles, Doubles, and/or All Events)
- League accomplishments (first place team, high individual game or series, etc)
- Other Tournament Accomplishments
- Special USBC Awards which could include:
 - Women (700 Series, 300 Game, and/or any other awards that are offered by USBC)
 - Men (750 Series, multiple 300's, and/or any other awards that are offered by USBC)
- Other Bowling Achievements

Veteran Bowler Category

This category is in honor of the late Irene Pevonka and the late Gene Kylan.

To qualify for the Veteran Bowler category, an applicant must have met at least three (3) of the following criteria:

- 30 Years of more bowled in the DeKalb Area USBC Association (does not have to be consecutive years)
- Participated in at least fifteen (15) or more local championship tournaments
- Participated in a state and/or national tournament
- Special USBC and/or league accomplishments

Sponsor Award

To qualify for the Sponsor Award, an individual/business must have sponsored a team in a league or tournament in the DeKalb Area USBC Association for at least 20 years (does not have to be consecutive).

Completed applications can be turned in to a member of the DeKalb Area USBC Association Hall of Fame Committee, a director of the DeKalb Area USBC Association, or the Association Manager. Completed applications can also be left at the bowling center counter to the attention of the Association Manager, Val Reborn. To be considered for this years Hall of Fame, nomination applications must be received no later than January 1, 2011.
